According to Muhammad Abdullah Gul.(May 30, 2019). (2017) Evaluating the Hybrid Threats' background informs its origins which supports it mostly to its zenith.

(David B H Denoon,2015). All these powers are super economically but are weak religiously and ethically. So these powers always try to hide their sins under the umbrella of economic power. Gambling



It does, however, mean that a portion of Islam considers itself in a Jihad against the U.S. Part of the professional responsibility of strategic intelligence analysis is to provide the context or “big picture” of this war, and thereby to paint the “picture” which will help clarify the operational/tactical intelligence analysis5.





On January 28th 2019, USA and the Taliban have drafted a framework under the peace negotiations within Afghanistan (Atwood & Robertson, 2019). In the result of these peace negotiations under the ceasefire, the USA required to pull all its military troops out from Afghanistan which were accepted by Taliban. Now concern is that how the NATO will survive for its strategic influence in this region; more over, the concern is that the American withdraws from this region

would simply allow the Taliban to return to power for Sharia Law implementation in Afghanistan, establishing their relations with Pakistan (How the Taliban Won, 2019).
